Subject:- Revalidation of unspent balance of GIA to Government of Odisha for running up of State Resource Centre for Women (SRCW) under National Mission for Empowerment of Women during F.Y. 2016-17.

Sir,

In continuation of this office earlier sanction order No. 1-21/2013-NMEW dated 30/03/2016 of FY 2015-16, I am directed to convey the authorization by the Competent Authority for carryover unspent balance of **Rs. 12,63,227/- (Rupees Twelve Lakh Sixty Three Thousand Two Hundred Twenty Seven Only)** to Government of Odisha for running up cost of SRCW-Odisha under National Mission for Empowerment of Women for FY 2016-17, subject to the following conditions:-

- That the funds sanctioned shall be utilized for the purpose for which it is sanctioned. A separate account in respect of the sanctioned amount is to be maintained.
- The Grant-in-aid is sanctioned by the Competent Authority subject to the condition that the norms, guidelines and conditions communicated from time to time from this office.
- The accounts of the SRCW/PSK/VCFS/State Govt. shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under provision of CAG (DPC) Act, 1971 and internal audit by the Principal Accounts Officer of the Ministry or Department whenever the Institution or Organization is called upon to do so.
- The Grant-in-Aid is towards the recurring & non-recurring expenditure and activities for running up of SRCW/PSK/VCFS under National Mission for Empowerment of Women as per approved pattern.
- The Grant-in-Aid released through this sanction order would cover liabilities/expenditure of SRCW/PSK/VCFS covering the **period upto 31/03/2017 only**. It may be noted that the funds, if remain unspent at the end of this Financial Year that is as on 31/03/2017, the same cannot be utilized without the prior concurrence by this Ministry.

2. National Mission for Empowerment of Women schemes shall be implemented on a sharing pattern at ratio of 60:40 between Central and State/UT Government respectively during FY 2016-17.

3. The annual budget towards running cost of SRCW at Odisha is Rs. 38,00,000/- (including one time establishment charges). On sharing ratio of 60:40 between Central and State/UT Government, Rs. 22,80,000/- lakh [60% of Rs. 38,00,000/-] is to be borne by Central Govt. and Rs. 15,20,000/- [40% of Rs. 38,00,000/-] is to be borne by State/UT Govt. during FY 2016-17.

4. State Govt. will submit the Utilization Certificate (UC) in GFR form 19A along with item-wise Statement of Expenditure (SOE) for PSK/SRCW project duly signed by the authorized State Govt. officer. The State Govt. shall also submit quarterly Progress Report on the Project as well as Demand for Funds on the SOE Performa before claiming next installment of GIA duly signed by the authorized State Govt. officer.
