**Subject:- Authorization for carrying over unspent balance of GIA of Rs. 19,14,000/- for the running cost of SRCW and allowing incurring of expenditure on the Scheme during FY 2016-17.**

Sir,

In continuation of earlier Sanction Order for an amount of Rs. 23.34 lakhs of even no. dated 6/07 /2015, I am directed to convey the authorization for utilization of carryover of unspent balance of **Rs. 19,14,000/- (Rupees Nineteen Lakh Fourteen Thousand Only)** as on 31.03.2017 for incurring expenditure during F. Y. 2016-17 by the Competent Authority. NMEW Scheme shall be implemented on sharing pattern at ratio of 60:40 between Centre and State, accordingly the state is authorised to utilise Rs. 11,40,000/- i.e. 60% of Rs. 19,00,000/- lakhs and Rs. 7,60,000/- i.e. 40% of Rs. 19,00,000/- to be borne by the Centre and State Govt. respectively subject to the following conditions:-

- The Grant-in-Aid is towards recurring expenditure for running cost of SRCW in the State on the SRCW Scheme during Financial Year 2016-17.
- The norms and guidelines already communicated by NRCW/NMEW and conditions contained in the Sanction Order may be adhered to.
- The payment already released will be subject to final adjustment in the light of the audited figure of admissible expenditure up to FY 2016-17.
- It may be noted that the funds, if remain unspent at the end of this Current Financial Year that is as on 31/03/2017, the same cannot be utilized without the prior concurrence/re-validation by this Ministry.

2. It may also be noted that next instalment of GIA under this Scheme shall be released only after proper Utilization Certificate along with Statement of Expenditure (SOE) with details for the relevant Financial Year is furnished.
