SANCTION ORDER

Subject: - Release of 1st installment of GIA for FY 2016-17 to the Government of Haryana towards running up of State Resource Centre for Women (SRCW) under NMEW, MWCD during FY 2016-17.

I am directed to convey the approval of Competent Authority to release 1st installment of GIA of **Rs. 10, 20, 000/- (Rupees ten lakh twenty thousand only)** towards running up of SRCW under National Mission for Empowerment of Women, Ministry of Women & Child Development during FY 2016-17 and to revalidate the unspent amount of Rs. 1,18,000/- of FY: 2015-16.

- National Mission for Empowerment of Women schemes shall be implemented on a sharing pattern at ratio of 60:40 between Central and State Govt. respectively. Further, the annual GIA for the FY: 2016-17 towards running up of SRCW is Rs. 38.00 lakh.
- The State Govt. is authorized to make an expenditure of Rs. 19.00 lakh [i.e. 50% of annual GIA] on sharing pattern at ratio of 60:40 between Central and State Governments. Accordingly, out of Rs. 19.00 lakh, Rs. 7.60 lakh [40% of Rs. 19.00 lakh] has to be borne by State Govt. The remaining 60% will be borne by the Central Govt.
- The Grant-in-aid is sanctioned by the Competent Authority subject to the condition that the norms, guidelines and conditions communicated from time to time from this office.
- The State Government shall furnish progress of expenditure of the grants released to them.
- It may be noted that the funds, if remain unspent at the end of this Financial Year that is as on 31/03/2017, the same cannot be utilized without the prior concurrence by this Ministry.
- The amount of grant-in-aid is finally adjustable in the books of the Principal Pay and Account Office, Ministry of Women and Child Development, Shastri Bhawan, New Delhi- 110001. The payment to the State would be arranged through the Reserve Bank of India, Nagpur Branch. The State Accountant General will send intimation regarding receipt of Grant-in-aid to the Principal pay & Accounts Office, Ministry of Women and Child Development, Shastri Bhawan, New Delhi.
