SANCTION ORDER

Subject: - Release of 1st installment of GIA to the Government of Karnataka towards running up of State Resource Centre for Women (SRCW) under NMEW, MWCD during FY 2016-17.

I am directed to convey the sanction of Competent Authority for release 1st installment of GIA of **Rs. 4,72,000/- (Rupees four lakh seventy two thousand only)** to Govt. of Karnataka after adjusting unspent balance of Rs. 6,68,000/- of FY 2015-16 towards running up of SRCW under NMEW, MWCD for FY 2016-17. Competent Authority has also authorized the Govt. of Karnataka to utilize unspent balance of Rs. 6,68,000/-.

2. National Mission for Empowerment of Women schemes shall be implemented on a sharing pattern at ratio of 60:40 between Central and State Govt. respectively. The annual budget towards running up cost of SRCW is Rs. 38.00 lakh.

3. On sharing ratio of 60:40 between Centre & State Govt., Rs. 22,80,000/- (60% of Rs. 38,00,000/-) will be borne by Centre Govt. and Rs. 15,20,000/- (40% of Rs. 38,00,000/-) will be borne by State Govt.. It is to note that grant release of Rs. 4,72,000/- + Rs. 6,68,000/- (revalidated unspent balance of FY 2015-16) = Rs. 11,40,000/- is 1st instalment of 50% out of Centre Govt. share of Rs. 22,80,000/- of FY 2016-17.

4. The grant is subject to the following conditions:-

- (i) That the funds sanctioned shall be utilized for the purpose for which it is sanctioned. A separate account in respect of the sanctioned amount is to be maintained.
- (ii) The accounts of the SRCW/PSK/VCFS/State Govt. shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under provision of CAG (DPC) Act, 1971 and internal audit by the Principal Accounts Officer of the Ministry or Department whenever the Institution or Organization is called upon to do so.
- (iii) The Grant-in-Aid is towards the recurring & non-recurring expenditure and activities for running up of SRCW/PSK/VCFS under National Mission for Empowerment of Women as per approved pattern.

- (iv) The Grant-in-Aid released through this sanction order would cover liabilities/expenditure of SRCW/PSK/VCFS covering the **period upto 31/03/2017 only**. It may be noted that the funds, if remain unspent at the end of this Financial Year that is as on 31/03/2017, the same cannot be utilized without the prior concurrence by this Ministry.
5. The Grant-in-aid is sanctioned by the Competent Authority subject to the condition that the norms, guidelines and conditions communicated from time to time from this office.
6. State Govts. will submit the Utilization Certificate (UC) in GFR form 19A along with item-wise Statement of Expenditure (SOE) for SRCW project duly signed by the authorized State Govt. officer.. The State Govt. shall also submit quarterly Progress Report on the Project as well as Demand for Funds on the SOE Performa before claiming next installment of GIA duly signed by the authorized State Govt. officer.
7. The amount of grant-in-aid is finally adjustable in the books of the Principal Pay and Account Office, Ministry of Women and Child Development, Shastri Bhawan, New Delhi- 110001. The payment to the State would be arranged through the Reserve Bank of India, Nagpur Branch. The State Accountant General will send intimation regarding receipt of Grant-in-aid to the Principal pay & Accounts Office, Ministry of Women and Child Development, Shastri Bhawan, New Delhi.
8. The expenditure involved is debit to Demand No. 97, Major Head No. 3601 – Grants-in-Aid to State Government, 03- Grants for Central Plan Schemes, 356 – Women's Welfare, 02- Protection and Empowerment of Women, Detailed Head 01- National Mission for Empowerment of Women (NMEW), Object Head 02.01.31 – Grant-In-Aid (General) for the current FY- 2016-17.
