SANCTION ORDER

Subject: Release of GIA to UT Administration of Puducherry towards 1st installment for FY 2016-17 for SRCW project under NMEW, MWCD during FY 2016-17.

I am directed to convey the sanction of competent authority for release of GIA for an amount of **₹10,15,728/- (Rupees ten lakh fifteen thousand seven hundred twenty eight only)** to UT Administration of Puducherry towards 1st installment for FY2016-17 for SRCW project after adjusting the unspent balance of ₹1,24,272/-. UT Administration of Puducherry is also authorized to utilize the unspent balance amount of ₹1,24,272/- lying with them. The grant is subject to the following conditions:-

- (i) That the funds sanctioned shall be utilized for the purpose for which it is sanctioned. A separate account in respect of the sanctioned amount is to be maintained.
 - (ii) The accounts of the SRCW/State Govt(s)/UT Admn. shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under provision of CAG (DPC) Act, 1971 and internal audit by the Principal Accounts Officer of the Ministry or Department whenever the Institution or Organization is called upon to do so.
 - (iii) The Grant-in-Aid is towards the recurring & non-recurring expenditure for running up of SRCW under National Mission for Empowerment of Women as per approved pattern.
 - (iv) The Grant-in-Aid released through this Sanction Order would cover liabilities of SRCW Project covering the **period up to 31/03/2017 only**. The unspent GIA, if any at the close of F.Y. 2016-17, the State Govt(s). shall seek revalidation of funds before incurring any expenditure beyond 31/03/2017.
2. Expenditure for SRCW shall be incurred as per above conditions and the revised instructions issued by this office from time to time.
 3. National Mission for Empowerment of Women schemes shall be implemented on a sharing pattern at ratio of 60:40 between Central and State Government respectively.

4. The annual budget towards running cost of SRCW is ₹38,00,000/- excluding one-time establishment cost for DCFS, TCFS & VCFS. On sharing ratio of 60:40 between Centre & State Govt(s)/UT Admn., ₹22,80,000/- (60% of ₹ 38,00,000/-) will be borne by Centre Govt. and ₹15,20,000/- (40% of ₹38,00,000/-) will be borne by State Govt(s)/UT Admn.. It is to note that this grant release of ₹10,15,728/- + ₹1,24,272/- (unspent balance of FY 2015-16) = ₹ 11,40,000/- is 1st instalment of 50% out of Centre Govt. annual share of ₹22,80,000/- of FY 2016-17.

5. State Govt(s)/UT Admn. will submit the Utilization Certificate (UC) in GFR form 19A along with item-wise Statement of Expenditure (SOE) for PSK/SRCW project duly signed by the authorized State Govt(s)/UT Admn. officer. The State Govt(s)/UT Admn. shall also submit quarterly Progress Report on the Project as well as Demand for Funds on the SOE Performa before claiming next installment of GIA duly signed by the authorized State Govt(s)/UT Admn. officer.


6. The amount of grant-in-aid is finally adjustable in the books of the Principal Pay and Account Office, Ministry of Women and Child Development, Shastri Bhawan, New Delhi- 110001. The payment to the State would be arranged through the Reserve Bank of India, Nagpur Branch. The State Accountant General will send intimation regarding receipt of Grant-in-aid to the Principal pay & Accounts Office, Ministry of Women and Child Development, Shastri Bhawan, New Delhi.

The expenditure involved is debitible to Demand No. 97, Major Head No. 3602 – Grants-in-Aid to UT Administration, 03- Grants for Central Plan Schemes, 356 – Women's Welfare, 01- Protection and Empowerment of Women, Detailed Head 01- National Mission for Empowerment of Women (NMEW), Object Head 01.01.31 – Grant-In-Aid (General) for the current FY- 2016-17.
