SANCTION ORDER

Subject: - Release of 1st instalment of GIA for FY 2016-17 to the Government of Rajasthan towards running up of State Resource Centre for Women (SRCW) under NMEW, MWCD during FY 2016-17.

I am directed to convey the sanction of Competent Authority for release 1st instalment of GIA of **Rs. 11,35,000/- (Rupees eleven lakh thirty five thousand only)** towards running up of State Resource Centre for Women (SRCW) under NMEW, MWCD during FY 2016-17 after adjusting unspent balance of Rs. 5000/- which was lying with the State Govt. during FY 2015-16. NMEW Scheme shall be implemented on sharing pattern at ratio of 60:40 between Centre and State, accordingly the state is authorised to utilise Rs. 11,40,000/- i.e. 60% of Rs. 19,00,000/- lakhs and Rs. 7,60,000/- i.e. 40% of Rs. 19,00,000/- to be borne by the Centre and State Govt. respectively. The State Govt. also authorised to utilise unspent balance of **Rs. 5,000/-** during the F.Y. 2016-17 subject to the following conditions:

- The Grant-in-aid is sanctioned by the Competent Authority subject to the condition that the norms, guidelines and conditions communicated from time to time from this office.
- The State Government shall furnish progress of expenditure of the grants released to them.
- It may be noted that the funds, if remain unspent at the end of this Financial Year that is as on 31/03/2017, the same cannot be utilized without the prior concurrence by this Ministry.

2. The amount of grant-in-aid is finally adjustable in the books of the Principal Pay and Account Office, Ministry of Women and Child Development, Shastri Bhawan, New Delhi- 110001. The payment to the State would be arranged through the Reserve Bank of India, Nagpur Branch. The State Accountant General will send intimation regarding receipt of Grant-in-aid to the Principal pay & Accounts Office, Ministry of Women and Child Development, Shastri Bhawan, New Delhi.

3. The expenditure involved is debitible to Demand No. 97, Major Head No. 3601 – Grants-in-Aid to State Government, 03- Grants for Central Plan Schemes, 356 – Women's Welfare, 02- Protection and Empowerment of Women, Detailed Head 01- National Mission for Empowerment of Women (NMEW), Object Head 02.01.31 – Grant-In-Aid (General) for the current FY- 2016-17.
