SANCTION ORDER

Subject: - Release of 1st installment of GIA for FY 2016-17 to the Government of Sikkim towards running up of State Resource Centre for Women (SRCW) under NMEW, MWCD during FY 2016-17.

I am directed to convey the sanction of Competent Authority for release 1st installment of GIA of **Rs. 17,10,000/- (Rupees seventeen lakh ten thousand only)** to Govt. of Sikkim towards running up of SRCW under NMEW, MWCD during FY 2016-17.

2. Since, State of Sikkim being a NE State, National Mission for Empowerment of Women schemes shall be implemented on a sharing pattern at ratio of 90:10 between Central and State Govt. respectively during FY 2016-17. Further, the annual budget towards running up cost of SRCW is Rs. 38.00 lakh.
3. On sharing pattern at ratio of 90:10 between Centre & State Govt., Rs. 34,20,000/- (90% of Rs. 38,00,000/-) will be borne by Centre Govt. and Rs. 3,80,000/- (10% of Rs. 38,00,000/-) will be borne by State Govt. during FY 2016-17. It is to note that this grant release of Rs. 17,10,000/- is 1st instalment of 50% out of Centre Govt. share of Rs. 34,20,000/- of FY 2016-17.
4. The Grant-in-aid is sanctioned by the Competent Authority subject to the condition that the norms, guidelines and conditions communicated from time to time from this office.
5. The State Government shall furnish progress of expenditure of the grants released to them.
6. It may be noted that the funds, if remain unspent at the end of this Financial Year that is as on 31/03/2017, the same cannot be utilized without the prior concurrence by this Ministry.
