**SANCTION ORDER**

Subject: - Release of 1<sup>st</sup> instalment of GIA for FY 2016-17 to the Government of Uttarakhand towards running up of State Resource Centre for Women (SRCW) under NMEW, MWCD during FY 2016-17.

I am directed to convey the sanction of Competent Authority for release 1<sup>st</sup> instalment of GIA of **Rs. 10,83,000/- (Rupees ten lakh eighty three thousand only)** as Central Govt. share after adjusting unspent balance of **Rs. 6,27,000/-** of FY 2015-16 towards running up of State Resource Centre for Women (SRCW) under NMEW, MWCD during FY 2016-17. NMEW Scheme shall be implemented with a sharing ratio of 90:10 between Centre & State. Uttarakhand being a special category state, **10% share** i.e. **Rs. 1,90,000/- of Rs. 19,00,000/-** will be borne by them. The State Govt. also authorised to utilise the unspent balance of Rs. 6,27,000/- during the F.Y. 2016-17 for SRCW.

2. The Grant-in-aid is sanctioned by the Competent Authority subject to the condition that the norms, guidelines and conditions communicated from time to time from this office.
3. The State Government shall furnish progress of expenditure of the grants released to them.
4. It may be noted that the funds, if remain unspent at the end of this Financial Year that is as on 31/03/2017, the same cannot be utilized without the prior concurrence by this Ministry.
5. The amount of grant-in-aid is finally adjustable in the books of the Principal Pay and Account Office, Ministry of Women and Child Development, Shastri Bhawan, New Delhi- 110001. The payment to the State would be arranged through the Reserve Bank of India, Nagpur Branch. The State Accountant General will send intimation regarding receipt of Grant-in-aid to the Principal pay & Accounts Office, Ministry of Women and Child Development, Shastri Bhawan, New Delhi.
